4 Relating to judges of probate; to amend Section
5 35-2-57, Code of Alabama 1975, to specify the method for a
6 judge of probate to record that an electronic map or a plat
7 has been vacated.

8 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

9 Section 1. Section 35-2-57, Code of Alabama 1975, is
10 amended to read as follows:

11 "§35-2-57

12 When a map or plat or part thereof is vacated, the
13 judge of probate must, upon recording such vacation, do one of
14 the following:

15 (1) Where the most recent record is only a tangible map
16 or plat, write in plain letters across the record of the map
17 or plat, or the part so vacated, the word "vacated" and shall
18 also refer on the same to the volume and page in which the
19 instrument of vacation is recorded.

20 (2) Where the most recent record consists of an
21 electronic or digital image of a map or plat, record a
22 certificate indicating that the map or plat has been vacated,
23 and the certificate shall be made a part of the property
24 records to which it pertains."

25 Section 2. This act shall become effective on the first
26 day of the third month following its passage and approval by
27 the Governor, or its otherwise becoming law.
